Frequently Asked Questions

What is A.B.A.T.E.?

We are a State Motorcycle Rights Organization (S.M.R.O.) dedicated to educating riders, drivers, and elected officials about issues affecting motorcyclists.

We help fund a political action committee (*BikePAC*) that directly interacts with the legislature about motorcycles issues and bills that affect us.

What does "A.B.A.T.E." mean?

A.B.A.T.E. stands for *A Brotherhood Against Totalitarian Enactments*. The organization was formed when legislators passed bills adversely affecting riders without consulting them.

We also do business as *A Brotherhood Aimed Towards Education*.

Mission Statement

A.B.A.T.E. of Oregon, Inc. promotes motorcycle awareness, education, safety, and liberty through community involvement and legislative action.

What is BikePAC?

Founded in 1988, *BikePAC* members track legislation, brief officials, and report to A.B.A.T.E. about issues affecting motorcyclists.

A.B.A.T.E. and BikePAC Legislative Victories

1977 – Oregon helmet requirement repealed.

1979 – Rider safety program proposed by A.B.A.T.E.

1981 – *Team Oregon* rider safety legislation passed.

1988 – Voter referendum reinstates helmet requirement.

" *BikePAC* formed for motorcyclists' legislative efforts.

1995 – Motorcycle helmet definition standardized. (HB-3422)

1997 – Adult helmet freedom of choice bill passed, vetoed by governor.

1997 – Federal court equates federal testing standards with Oregon helmet definition.

1999 – Motorcycle handlebar height regulation repealed.

2001 – Riders given choice to fuel bikes at service stations. (HB-3885)

2001–2013

Hostile capitol environment to motorcycle legislative efforts.

2015 – "*Dead Red*" bill passes. (SB-533)

Riders allowed to proceed if light not triggered after one cycle.

2017 – Reckless drivers held accountable for motorcyclist harm. (HB-2598)

2019 – Drivers can be held criminally negligent for motorcyclist injuries. (SB-810)

Legislators didn't give motorcyclists these victories.

We had to work hard together to gain or regain our rights.

Why Columbus ?

Cultural Bike Show

(Personal views of the editor. Not to be confused with reality or endorsement by A.B.A.T.E. of Oregon.)

The tenth month of our calendar (named after the number eight) has traditionally been when Chris Columbus is celebrated as having "discovered" the Americas, which came as a surprise to the folks who had been living there for thousands of years.

As most people know by now, Columbus wasn't even the first foreigner to set foot on the Americas. The Norse had settlements in what is now northeast Canada for over five hundred years, beginning about 1000 AD. In addition there is growing evidence that storms or explorers brought people from Africa to the eastern shores of south America, Asian people to the Pacific northwest, and Polynesians to the west coast of south America.

So why does Columbus get so much credit in history ?

Mostly it was a matter of timing.

Overcrowded Europe was overjoyed to find that land existed to the west that could be used to relieve population pressures. That and the

promise of amazing riches to be had by those adventurous enough to sail across an ocean.

The invention of the moveable-type printing press half a century earlier meant that the Columbus expedition received far greater publicity in Europe than had Viking efforts, when printing was done by hand.

There was also the matter of what's called, the *Columbian Exchange*, where ideas, goods, and diseases flowed both ways across the Atlantic. Europe received many basic rights and governing ideas from tribal ways of living, food, plants, silver, and gold, followed by diseases contracted in warmer climates of the Americas. The Americas in turn had their populations decimated by European diseases and attempted cultural genocide in return for horses, metal, and alcoholism.

Does Columbus deserve a federally-recognized holiday mid-way through October ?

Based on his personal behavior of rape, enslavement, and murder the answer would have to be a resounding, "Hell no ! " But from a European/United States point of view, the answer might be an unenthusiastic, "Probably."

But those who most deserve recognition on that day are those who managed to persist in their way of life despite everything thrown at them by our culture -- the tribal people of the Americas.

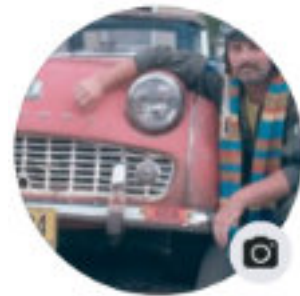
Cultural Bike Show

Being A Freedom Fighter Is Not A Spectator Sport

We are *A Brotherhood Against Totalitarian Enactments*, although a guest at any *A.B.A.T.E. of Oregon* meeting would be excused for not immediately recognizing it.

I've been told many times over many decades by members and leaders of this organization that "we are not interested in politics."

Really? Think that fact might have something to do with why membership in our organization continues to erode?

There's a lot to unpack in the above statements, so feel free to take your time thoughtfully pondering the subject before reading further.

I'll spare you the typical geezer blather about how "back in the day" *A.B.A.T.E.* was an organization of rabid freedom fighters who actually walked their talk. Most of them are now long in the ground. Soon, when you are no longer hearing from me that will be the signal that I have finally joined them. But until that day comes, I will fight governmental tyranny with every fiber of my being. If I have to do it sitting in a wheelchair, so be it. I will not be deterred by my fellow citizens who long ago surrendered their rights and freedoms that were earned with the blood and sacrifice of previous generations.

c.o.e. penned a compelling editorial recently promoting membership participation in the legislative process. While I agree that activities like *Biker Days* at the capitol are fun and productive, this is not the way to convince legislators to vote our way. Bike days are a component of the solution but not the solution itself.

Gordon Hieronimus hauling his little kids around the chambers in their radio flyer on *Biker Days* thirty years ago was quite the sight. He was educating his children, who are our future, on an important civics lesson. And demonstrating that motorcyclists have families left an indelible impression on many in Salem who might have previously held the view that we were just thugs and future organ donors. That and *Biker Days* are just fun to attend. So do I disagree with anything in the c.o.e. editorial? No, I do not.

However, writing letters and showing up the day of a vote is not the way to forward our agenda. And doing it that way for the past 40 years with very little to show for it is evidence of that.

The way to get legislation passed starts with making contact with future rule-makers the day that they file to run for a political office. And by becoming part of the political "grass roots". Yes, that means actually getting involved at the local level. And becoming a precinct committee person. (PCP)

In 2000, thirty-six *A.B.A.T.E.* members showed up as voting delegates at the *Democratic Party of Oregon* (DPO) state convention in Eugene, Oregon. On that weekend they got repeal of the mandatory helmet requirement for motorcyclists added to the DPO legislative agenda. It passed by one vote! I thought I would see pigs fly before I would ever see that but it shows what a few determined people and some hard work can accomplish.

I traveled to the various chapters later that year. There was always at least one member in attendance who was one of the thirty-six. I made a point of recognizing them and saying that if they had not been there, our massive victory would have never happened. I got a nice plaque from the *M.R.F.* for this accomplishment. But it wasn't me who did it. It was a team effort all the way. And like any team, if only one of them was a no-show, we would have lost. So if you're reading this and thinking, "What can I do? I'm just one person". You have your answer. You can do a *lot!*

Pigs flying over Eugene started when a few of us started showing up at monthly central committee meetings. And getting ourselves voted in as PCPs. A formality, really. No one ever gets *not* voted in. But no one was particularly thrilled to see us there and the hostility from some was palpable. But a couple of years later, these same folks who were not at all welcoming when we showed up were giving speeches at the convention in *support* of helmet requirement repeal. Why? Certainly not because they had a religious epiphany about my body, my choice when it comes to riding gear. It was because they started to see us as real people, members of the community. And more importantly, as friends with many, varied interests that they shared. That and democrats, for all of their misguided political goals, do love to party. And happily, so do we!

Invite me to speak at your chapter and I'll tell you how we made a lot of friends and built many bridges in the bar the night before the convention vote. And the incredible adventure at a Clackamas

County DPO auction where Cheryl Jessop (RIP) was voted into the top secret DPO "Bitch Caucus" where all real policy decisions are made.

I'll close this by telling you something you should already know. The tyranny during covid showed that many Americans no longer value their rights and freedoms, otherwise they wouldn't have submitted to it like sheep. And once you lose a right or a freedom the chances you will ever get it back are zero

We lost the freedom to wear or not wear a helmet thirty-seven years ago. Think you will ever be able to roll down your driveway without a helmet on ever again? I don't. Seems like a small thing now but think about all the rights and freedoms you've had taken away since then. We need to be on offense, not defense!

BikePAC of Oregon issues to discuss with legislators

A. Ethanol in fuel 2024 legislative focus areas position:

BikePAC aligns on this issue with a great many other citizens groups who oppose the addition of ethanol to be burned in many types of motors. This includes motorcycles, ATVs, boats, planes, classic cars, and thousands of smaller engines used to mow lawns, run generators, or pressure wash a driveway. The proven detrimental effects of ethanol are especially common in carbureted and air-cooled motors. BikePAC supports at least one pump containing non-blended fuel be available in all practical cases at Oregon filling stations. At a minimum, we oppose the proliferation of the E-15 blend from becoming a standard.

B. Driver crash accountability:

The word "motorcyclists" was removed from the language that became ORS 811.135 several sessions ago. (Termed the *Vulnerable Users Statute*.)

Motorcyclists maintain the position that larger vehicle operators should be held to a higher standard of accountability when it comes to the negligent injury or death of Oregon's "high-exposure" motorists, including motorcyclists on Oregon's roadways.

C. Gear choice:

BikePAC maintains the position that it is a rider's choice to select appropriate safety equipment for the riding conditions. This includes helmets, reflective apparel, or similar wearable items.

Safety gear, including helmet usage, should be similarly framed in regulations (as in thirty-one other states) to be the responsible choice for all licensed, endorsed, insured, adult Oregonians.

D. Lane-sharing:

BikePAC maintains that the con-

cept of lane-sharing for motorcyclists should be afforded in-depth vetting related to the positive affects for some of Oregon's heavy-traffic regions. Similar to California's provision in this regard, we believe that there are tangible positive impacts that can be made to some of Oregon's congestion issues, particularly in metro areas and rush-hour commutes. BikePAC maintains that there are additional positive environmental and safety benefits attached to such a provision.

E. Anti-profiling:

Similar to Washington state's recent SB-5242 (signed into effect,) BikePAC maintains a position to be ever cognizant of citizen constitutional rights, dignity, and fairness within the judicial system.

F. Autonomous vehicles:

BikePAC maintains that safety testing related to self driving technology's ability to sense the presence of a motorcycle should be transparent and available to the public, as this feature appears to be faulty.

G. Internal combustion engines:

As electric vehicles continue to emerge and evolve, BikePAC maintains support of all Oregon motorcyclists to continue operating their internal combustion machines on Oregon's roads, highways, and tributaries, and opposes any future ban on the engines themselves or our right to repair them.
