

OREGON GETS HELMET LAWS

RIDE FREE IN 82 ??

On Wednesday, April 8, Senate Bill 554 was before the Senate Transportation Committee in Salem, and testimony was heard. Most of it was in favor of the Helmet Law.

I said, MOST OF THE TESTIMONY WAS IN FAVOR OF THE MANDATORY HELMET LAW.

Now that I have your attention......your State Board of Directors has always tried to protect ABATE Members, and one way of doing this is to remind you all that there will ALWAYS be a Helmet Law introduced every Legislative Session in Oregon. If the Session goes on a yearly basis, instead of every two years, we will probably see it every year. Period. NOW IS THE TIME to do what we can do to defeat this thing. It is a whole lot easier to defeat the Bill than it is to repeal the Law. NEVER, NEVER, NEVER sit back and think you have killed the issue once and for all. As soon as you are not paying attention, it will slide through, and this time, we have a tough job ahead of us. The Bill was introduced and assigned to Committee very quickly. Slick. Testimony was heard April 8, and will also be heard on April 13, with a Work Session scheduled on Friday, April 17.

Here are some possibilities: the Bill will be voted on, passed, and then must pass on the House side, then go to the Governor, where he can sign it, or ignore it, in which case it becomes law; if he vetoes it, it should not. The Bill can be voted down by the committee, in which case the supporters of it can demand a re-vote. Then it could be passed at that point, even if it was defeated the first time. It can be tabled. If it is tabled at the time the Legislative Session closes, it will die a natural death, and must be re-introduced next Session. It will be.

NOW, ARE YOU STARTING TO GET THE PICTURE? Ok. Even though it may not seem like it, the biggest thing we have going for us as a group is writing letters. Now, newer Members may not agree with this, but history shows that our letters will do the job. Even if you feel like one letter from you won't do much, write anyway. Here's the thing. If our elected representatives in Salem get a form letter on a subject, they may not read it; it may very possibly go into the "round file". If they get a typewritten letter, they figure a couple more people agree with the writer, and stack it with the "for" or "against", as is fitting. BUT: if they get a hand written letter, even a "Please vote no on this, is fitting. BUT: if they get a better letter, even a "Please vote no on this, thank you", they figure that about ten other people agree with the writer, but just wouldn"t write a letter. So, your one letter is actually eleven votes against the Helmet Law. So do it.

Now, in the last Newsletter, there was some information about a Helmet Law, and hints on writing letters. That Helmet Law is a different one, that was introduced on the other side of the system: the House of Representatives. So, there are actually two Helmet Bills. It's a rule that if there are two Bills dealing with the same subject, only one can be tabled at a time; the other one must be worked on. So, even if we get the Senate Bill tabled, the House Bill will start cooking. For those of you who play chess, this is where they say "Check". I don't know about the rest of you, but I ain't waiting around for "Check-Mate". We will have the opportunity to give more testimony on April 13, and by the time this Newsletter hits the streets, there will be more information, so stay in touch with your local chapter. If you can't make the meetings, try to at least call one of your local officers and find out what is happening. If you have a friend handy, send them to the meeting to take notes for you. It's worth the hassle.

If you do nothing else within the first ten minutes after you read this, write a letter. The last Newsletter had good information on letter writing. If you don't have it, write to: Senate Transportation Committee, State Capitol, Salem Oregon 97310. If it is addressed to the committee, they all should get a copy. The Chairman of the Senate Transportation Committee is Senator Isham. The other members are: Wyers, Wingard, Smith, Groener. Bullock and Hartung. If one of these people represents the area you live in, write to that one and mention that you are a voter. It helps.



HOW TO WRITE YOUR LEGISLATOR

Use proper forms of address.

Legislators do want to hear from their constituents, however, letters should be brief and to the point. Follow these hints to get your message across.

- Always identify the bill number and subject matter.
 Write when the bills are being considered in commit
- Write to the legislator who represents you, not everyone.
- State why you support or oppose the legislation, and how it would affect you, your family, or business.
- Write in your own words, don't copy someone else's letter or just sign your name to a printed letter.
- Don't make any threats, be constructive.
- If a legislator does something that you appreciate, let him or her know.
- Only write about one subject per letter

ABATE OF OREGON FORMS LEGISLATIVE COALITION WITH AMA:

We have made the decision to form a Legislative Coalition with District 28 of the American Motorcycle Association. We have worked with the AMA during past Legislative Sessions, and feel the need for a pooling of resources, and a united front. It must be clearly understood that this is a temporary project, formed for the purpose of working during this Session only. It is a rather loosely structured thing. However, we welcome their support of our efforts, and though we have separate Bills to work on this time, we are all working toward the same goals.

BIKERS' RIGHTS:NOT

Ever feel like a minority? Motorcycle riders in Oregon are not a real "minority", according to the statistics on the number of registered motorcycles in this state. But, somehow, that just doesn't seem to cover it. Does it?

Back in the Soaring Sixties, when some folks were finding out that even Uncle Sam would back off if you put your "religion" up front, the Federal government would back off if you put your "religion" up front, the Federal government started asking itself "Just what the hell is a religion, anyhow?" deeply religious governmental heritage, they were sort of afraid to get into it too heavy, and we can suppose that by defining a religion very closely, they would in fact be inventing it, or making laws about it, which is a very tricky business for the government to get into, see. (At least in America, it is. So far.) But the issue was draft evasion during an undeclared war. They couldn't let that one slide too far. They couldn't have all those dirty hippies getting out of a haircut, bath and good old fashioned Army Discipline by hiding behind the Preachers' Robes. On the other hand, the Federal Government couldn't exactly face down righteously angry Quaker parents of eligible-aged sons, either. (Now THAT would have been a declared war.) To borrow a phrase "Oh, My God." How were they to drag their beaureaucratic asses through this one and come out of Well, here's what they did: it alive?

Rather than set up a definition of "what is a religion", they established guidelines for deciding whether or not a person's religion was in fact the issue. If so, that person could not be at the wrong end of different treatment directly because of that religion. Now, right away they ran into a problem with the word "religion", so they included the words "a set of sincerely held religious beliefs". In order for a belief to be "religious" in nature, the belief must indicate or otherwise motivate a certain standard of behavior (actions; what you do or don't do). The belief, or "set" of beliefs must also hold a position of importance in your life that is equal or equivalent to the beliefs and following actions of the ones held by a person who belongs to an "orthodox", or well-recognized Church. (We all know what American Churches are.) HOWEVER, thefact that a belief or set of beliefs is not ordinary (orthodox), familiar, well-recognized, or otherwise widely held by others, is NOT an indication that the belief is NOT a religion. In other words, just because you never heard of it before, doesn't mean it ain't so. The only test of a religion, therefore, is not whether the judge in question has heard of your religion, or whether he belongs to it, or whether he disagrees with it, but rather, your "sincerity of belief".

Now, how you gonna know if a guy is "sincere" in his belief? Let me give you an example. If you worked for a company that made everybody take turns working weekends, and after two years, you decided you would refuse to work weekends, and they said you better work weekends or you're fired, well you could say "It's against my religion to work on Saturdays." So, your boss would check you out and find out you just joined a church which had that doctrine, say, two weeks ago. Right there, your sincerity of belief might be questioned, especially when you had been doing a lot of talking about going hunting this year. However, let's say you had been attending the church for two or three years, had been taking 'instruction', and therefore had just joined formally because you needed the instruction period, and time to check it out etc before you made it formal. So then your beliefs with this church might in fact be very sincere. This is a very simple example, and there are a lot more questions to be asked and answered in order to make a decision in a specific case, but this is the general idea. cont'd ...

BIKERS' RIGHTS, cont'd.

NOW, lets look back at motorcycle riders. How do YOU feel about being free to ride? If your employer told you to get rid of your motorcycle or go find another job, how would you react? And, if it really came down to it, would you let your job go, or sell your bike? See, if you don't have a job, you won't have the money to hire a lawyer to sue your boss. If you keep your job and sell your scoot, you will have the money, but you won't be free to ride. Get it? Right where it hurts. So when it comes to going into a restaurant and being refused service because you came in on a motorcycle, it's so easy to just go on down the road....compared to jail time for letting the management know how you feel about their discriminatory policies, that is. Plus getting you head beat in by a public servant, in the Name of the Law, maybe, huh? We are posing these questions so that you as an individual can decide, or at least think about, how important riding a motorcycle is in your life.

For some of us, being free to ride and pursue our lifestyle as motorcycle riders is as important in our lives as going to church every Sunday is to members of say the Catholic church. (The examples are endless, here in the Land of the Free.) So how come our beliefs aren't protected the way they are for other people, just because their religion dictates that they go inside a building and chant words together, etc, and we don't? I thought the government didn't specify what you had to do in order to be a religion? Well, we are protected, but that protection is untested in a court of law. The government does not specify, but they do control the courts. See? There are Class-Action lawsuits filed on behalf of motorcycle riders on this issue, but that is not the purpose of this writing. The purpose is to provoke thought in you, the rider. The purpose is to let you know that there is a Biker's Church in Oregon, and it is not affiliated with any other organization. It does not have a building, but could if you wanted to be in one. It does not ask for money, but could use it. It does not recruit Members, but wants to let you know it is here. It could provide you with legal protection of your rights, but it helps if you are a Member of Record. Most Members are Members in Spirit, because it is such a personal and delicate issue, that it is difficult to discuss, even with friends. It's none of most people's business. But it's real.

And, the purpose is to let you know, when you might be feeling beaten down as a biker, thatyou are right to want to be free. You are right to want to live, and live free as a motorcycle rider. You are right to want to try to be happy in your own way, and mind your own business while doing it. Doesn't that sound a lot like "Life, Liberty, and the Pursuit of Happiness"? It is, man, it is. We are here. Biker's Church: "Autonomy-Power-Freedom" With love and respect.




