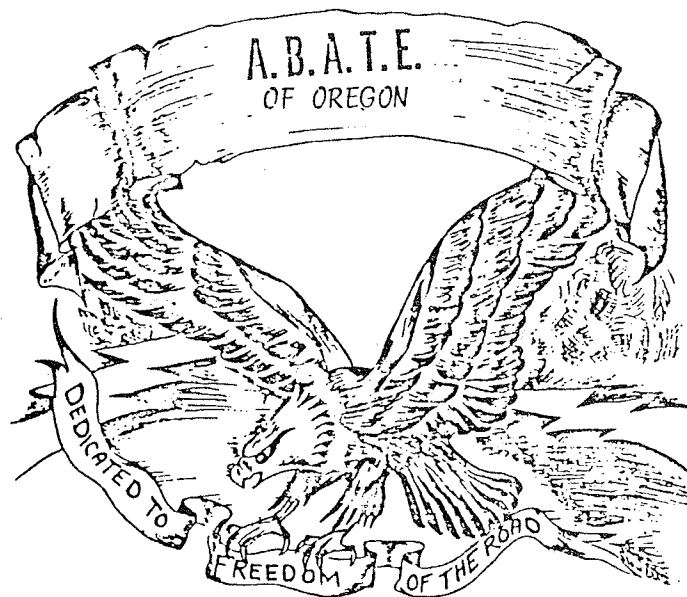

ORGANIZATIONAL STRUCTURE

There has been a lot of misunderstanding among members on how an Organization works, so I'm going to try to give it a brief but thorough explanation!!

First of all, ABATE is one Organization with segments (chapters) throughout the State!! These chapters are governed by the State and must comply with the State's rules of operation. They can, in addition to the State's rules, add their own, but must still comply with State standards. The chapters have fund raisers, etc., and are required to send 25% net profit, unless profit was less than \$50 or put on for a non-profit organization (like Easter Seals, Muscular Distrophy, etc) to the State. Chapter funds are a part of the State's treasury and a quarterly report must be submitted.

Each chapter has 2 reps that go to State meetings and express your chapter views, vote, and pass on information. Each chapter is represented at the Board, and are a part of the Board. State officers are elected from the Board. If the Board votes on an issue, (such as the ambulance) all chapters must comply with the Board's decision. Chapters must remember that you are ABATE OF OREGON!! Not ABATE of certain counties. In Jackson County we say "ABATE OF OREGON, JACKSON COUNTY CHAPTER". If you are a member without a chapter, you lose out on Board discussion and representation.

In laymans terms, the Board is made up of chapters, the State treasury is all the finances throughout the State and "we don't have to wear a helmet for 2 more years!!"

"One worthy bill that was introduced, only to vanish from sight, was the one

which would have brought back the mandatory use of helmets for motorcycle riders. Such a bill once was law, but many cyclists thought it infringed on their freedom of choice, and they succeeded in having it repealed (except for riders under 18) and killed any attempt to revive it.

Most riders of motorcycles-the smart ones-wear helmets, law or no law. But some persist in flouting the odds.

A friend who owns a motorbike for recreational riding put it to me this way: "I had a spill soon after I got my bike", he said. "It skinned up my arm and shoulder which wasn't too bad. But when I felt the bump on my noggin that was cushioned by the helmet, it made a believer of me".

He believes he would have been killed or seriously injured if it hadn't been for the helmet, and before-and-after statistics bear out that belief.

Lacking legislative action, one would think that insurance companies would charge a hefty premium for bike riders who don't use helmets.

And why should the rest of us pay the costs of funerals, or medical care, or increased insurance premiums, that result directly from unhelmeted motorbike riders who persist in going helmetless? - E.A.

ABATE OF MISSOURI SUBMITTED THIS ARTICLE:

BELL TO APPEAL \$3 MILLION VERDICT:

Bell Helmets Inc. says it will appeal a New York jury verdict against it and two other defendants that awarded \$3 million to a woman involved in a motorcycle accident who was wearing a Bell helmet. The jury found that 28 year old Denise Cornier was entitled to the settlement because the helmet failed to provide adequate protection. Cornier's attorney said she was in a coma for 7 weeks and suffered "severe brain damage". The award was against Bell, the operator of the motorcycle and the driver of a car also involved in the accident, which took place in August 1977. According to Bell senior vice president Dean Fisher, the helmet met all applicable standards at the time and "we feel it is a tribute to Bell quality standards that the woman is alive today". While the plaintiff charged the helmet, a 1976 Bell Super Magnum that met all DOT standards, had failed a test procedure, Fisher noted there was "sufficient evidence to question the validity and accuracy of that test". The same model had passed the test on 2 previous occasions, Fisher said. No date has been set for the appeal.

Rick Chouinard, President of ABATE of South Dakota:

ABATE stands against mandatory bills that restrict our freedom. WE also stand for freedom of choice and education of the inexperienced rider. This means that if a person wants to wear a helmet they should be allowed to. Those that won't allow their spouse to wear one or gives a fellow rider a hard time for wearing one are in the wrong. Freedom of choice is the reason we fought the helmet law. If a person feels more comfortable with a helmet, they will be a better rider when wearing it. This is also true for passenger comfort. So let the person on the bike, both front and back, make their own choice. That's what we fought the mandatory helmet bill for. THAT'S FREEDOM!!!! (Thanks Rick. Good point)

NOISY PIPE? FINE THE DEALER!

The noisy exhausts produced by a few irresponsible aftermarket manufacturers are the cause of much ill will directed at motorcyclists. Most areas have provisions for penalizing the owner and rider of noisy motorcycles, but Britain has gone one step further with a new law that will fine the dealer who sells any illegally loud system. The fine may be well over \$100....

JOIN A HOG

Harley Davidson Motor Co., has introduced a new HOG, but you don't ride it, you join it and then go riding. "HOG" stands for a new motorcycle club, The Harley Owners Group. The club has 5 chapters: Big Twin, Touring, Antique, Sporster or International. Membership fee is \$30. HOG's most significant benefit is this industry first: The Harley Davidson Fly and Ride Program. Under this program club members can fly to a prime vacation spot and rent a Harley FXRS Super Glide II or FLT Tour Glide. Rental rates in the US will be approximately \$250 per week. Inaugural Fly and Ride cities are Orlando and Miami, Honolulu and Frankfurt West Germany. Purchasers of 1983 model motorcycles will receive a free one year membership. For full details, see your local authorized Harley Davidson dealer.

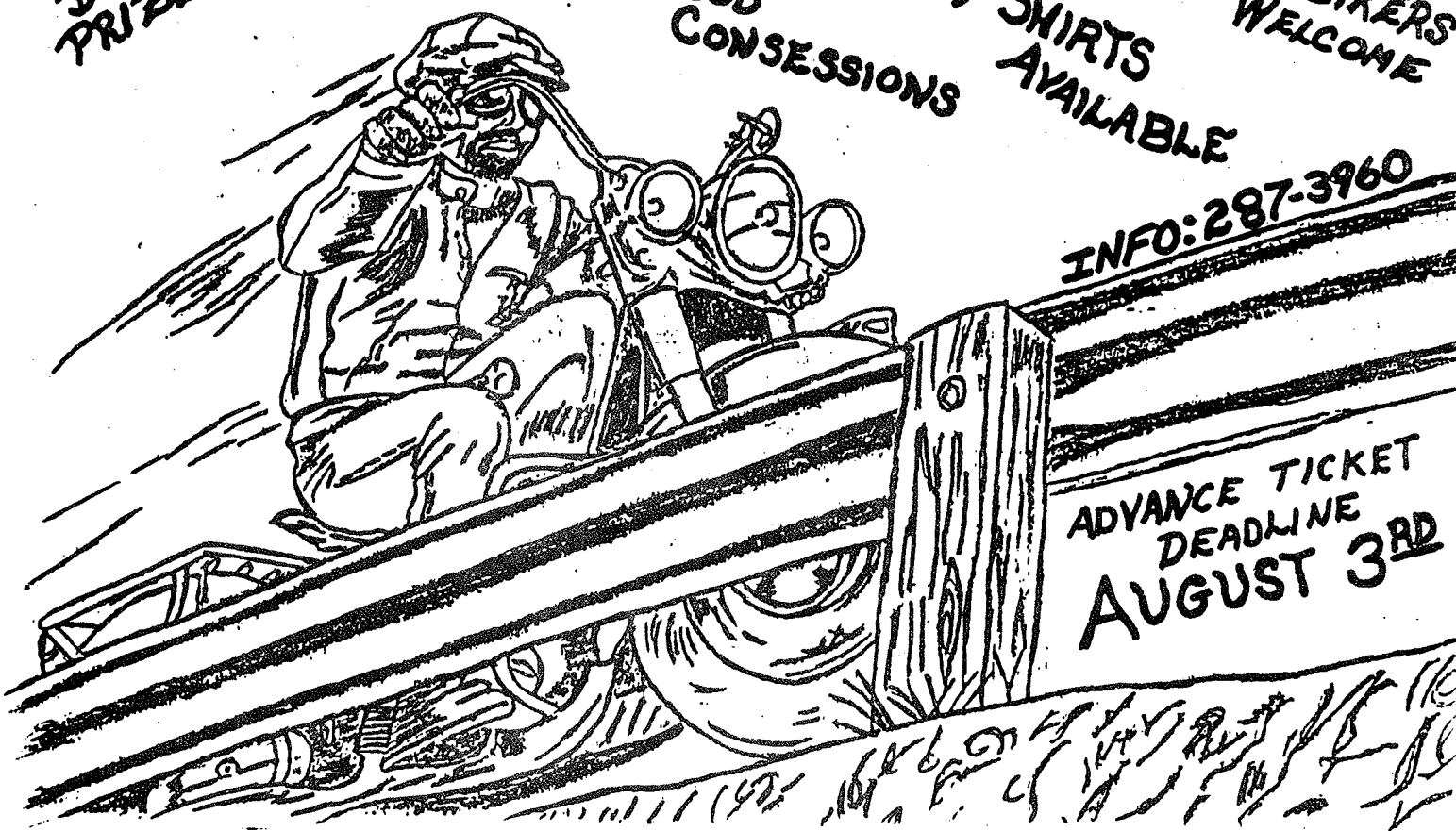

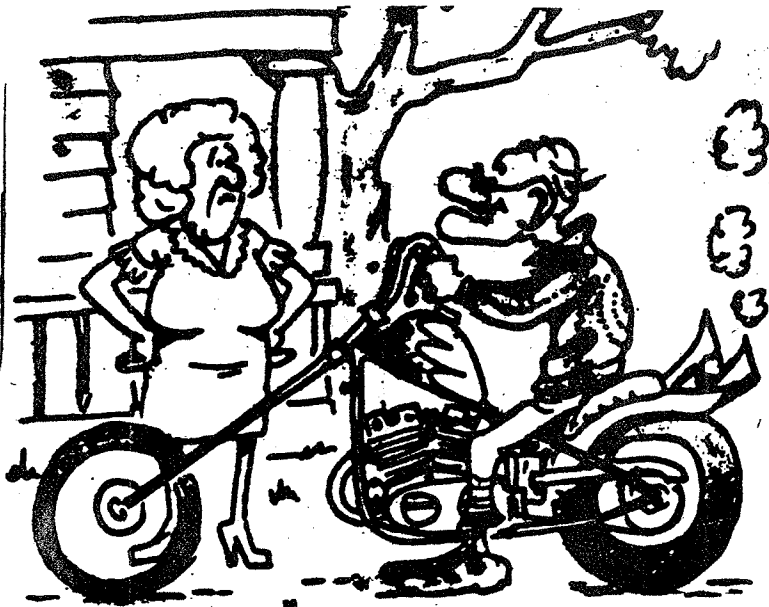

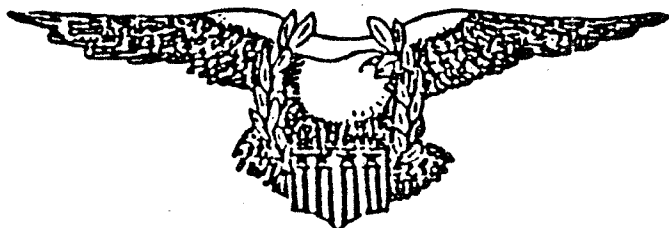
