

\*\* STATE BOARD MEETING HIGHLIGHTS \*\*

Since I haven't done a State Board report for a few months, I'm going
to combine the notes from the October and November meetings into one report
so everyone will know what's been happening. First of all, our bank balance
for the period covering both meetings stands at about \$2795, distributed
among three accounts. Those of you wishing to see a breakdown of our State
finances can get in touch with your own chapter's State Rep - he or she is
provided with a hand-out at each board meeting that shows a break down of
our finances - Louise is doing an excellent job of keeping things in order!

Al Cole wants to thank everyone who sent cards and flowers during his recovery from surgery. He also wants to remind everyone that he will NOT accept personal checks for either renewals or new members! CHAPTER CHECKS OR MONEY ORDERS ONLY!! Also, if you send cash thru the mail, it's at your own risk. When you fill out your application, either for new or renewals, PLEASE PRINT CLEARLY, AND USE YOUR GIVEN NAME - NO NICKNAMES OR HANDLES!!! The Postal Service has to have a proper name and address, or your membership package and newsletters'll wind up in the round file!! Along the same subject, yours truly, as Newsletter Editor, would like to remind everyone that sometimes the Postal Service screws up and fails to deliver your newsletter, even if it IS properly addressed. Mine was not delivered to me in November, and I've missed various months before. I'm assisting Al in keeping our mailing list at AD-MAIL up to date - along with a lot of help from Laura of West Portland Chapter, we've managed to lower our error rate tremendously. Still, if you haven't received a newsletter more than two months running, see one of us at our chapter meetings or have your Chapter Rep let us know at a State meeting, so we can get it straightened out. Also, please let your Membership Secretary know when you move - our last address correction request cost us about \$28 in returned newsletters. Quite a few of these were labeled "UNDELIVERABLE - NO FORWARDING ADDRESS". When we get these back, the people are dropped from our mailing list, no matter how much longer their membership has to run! It costs us about 75c a month to mail each newsletter, and we don't want 'em winding up in the trash!

The ambulance was a topic of much discussion at the October meeting. It was decided (voted on) to allow Dr. Dave of NE Portland to continue as sole director of the ambulance. He is to make regular (at least quarterly) reports, in person, to the State Board on the status of the vehicle, which is to be licensed and insured as a STANDBY VEHICLE. Basicly, a standby vehicle is able to serve only as a mobile first-aid station, and can be used as transport in life-threatening situations only; these are situations in which a "regular" ambulance, such as A.A., Alpine, Buck, etc., would be unable to reach an accident site and transport a victim to an emergency facility in time to save his or her life. It was decided that we, as an organization, could not begin to afford to insure the vehicle as a true ambulance, so in the future, although it will probably continue to be called an "ambulance", it will not be one in the true meaning of the word.

#### (State Board Report continues)

We now have a regular printer for items such as stationery, envelopes, membership forms, etc. Doug Porter (Griz) of Bend Chapter will do it all for cost in exchange for a lifetime membership. The newsletter, however, will continue to be printed by Action Copy of Portland, for the forseeable future at least. This allows me a bit more time to get things done, in that all the places I have to deal with on a monthly basis (printer, house, P.O. box, and location of our bulk mail permit) are in a central location - namely, Portland. Once I am no longer the Editor (that's right, I'm stepping down when my term is done in June '85), anything could happen! Personally, I feel that whoever is elected as Newsletter Editor should live in the Portland area, simply because the P.O. Box and the bulk permit are located at the main Post Office downtown. It's more difficult than can be imagined to get a permit changed to a different Post Office, and it'd be as difficult to change the location of the P.O. Box as well. I hope someone from one of the Portland area chapters will consider taking over the post in July 1985.

An Emergency Advisory Board was formed at the November meeting; it is composed of five officers - Coordinator, Vice-Coordinator, Secretary, Treasurer, and Membership Secretary. Their fuction will be to handle problems that cannot wait for the next regularly scheduled Board Meeting.

Fossil '85 is in the planning stages - looks as if it'll be held at Shelton Wayside during Memorial Day weekend. Cost is higher this year @ \$15 solo and \$20 couple at the gate, and \$12 solo, \$18 advance. (I don't plan to attend this year, as my second child is due to be born on May 25th.) As long as I'm talking about Fossil, I'd like to point out that, because of the way in which our (A.B.A.T.E. of Oregon, Inc.) insurance policy is written, we cannot sell liquor in any way, shape or form. (Hard stuff). Can't sell cups intended to be filled with liquor, either. We can't hold raffles of any kind either. At least, it can't be called a raffle. Don't look at me people - I just type up what's on a report!

We need a Legislative Director! Teresa is a bit overburdened by wearing two hats, and feels that trying to do two jobs and give them each 100% will result in both jobs suffering, terminal burn-out, or both! The State Legislature will convene in January, and we need someone who can stay on top of the situation in Salem. ## \*\* KLAMATH FALLS CHAPTER \*\* EULOGY FOR JACK ARGETSINGER



Prior Planning Prevents Pretty Poor Putting, Pleasures, Practices, Programs, Partys, Participation, Prerequisites, and Prohibitions. Just because I'm away from Klamath Falls for a while doesn't mean I'm not interested or concerned with what ABATE is doing. We all (like "you all", but it's going to be WE all) are going to have to start following the "P" Rule precisely. Starting in January, a very influential group of people with a bunch of money and interests in the helmet industry will start trying to get richer by getting a mandatory helmet law re-instated in Oregon. This plan is completely unacceptable! NOW IS THE TIME TO PLAN HOW YOU ARE GOING TO PREVENT HELMETS FROM BECOMING A PROHIBITIVE PREREQUISITE PREVENTING PLEASURABLE PUTTING, PARTY-ING PARTICIPATION PRACTICES.

The question is not WHAT can you do, but what WILL you do? There's another "P" - Procrastinate. ## Survival skills will be taught to motorcyclists

A statewide motorcycle safety campaign approved by the Oregon Traffic Safety Commission will come to Roseburg Saturday in the form of an eight-hour class for experienced motorcyclists.

The Better Biking Program, taught by Ed Halkyard of Roseburg, is scheduled to start at 9 a.m. in the parking lot of the Douglas County Justice Building.

Halkyard, certified as an instructor by the Motorcycle Safety Foundation, says the safety class will focus on such motorcyclists' survival skills as braking, turning, countersteering and slow maneu-

The class also will cover such topics as a rider's mental preparation for riding in traffic and a rider's ability to detect and avoid road hazards.

The class is intended for motorcycle riders with at least six months experience, Halkyard says.

The Better Biking Program will be sponsored locally by the Douglas County chapter of ABATE of Oregon, Inc., a non-profit organization founded to represent motorcycle riders in issues involving motorcycle safety.

ABATE of Oregon received a grant from the Oregon Traffic Safety Commission to present the safety classes. The grant, funded by a portion of the state's motorcycle endorsement renewal fees, is one of several recently approved by the safety commission as part of its "Team Oregon" motorcycle safety project. Other grant recipients were Clackamas, Lane

nd Rogue community colleges, and Oregon State University.

The goal of "Team Oregon" is to promote motorcycle safety through a combination of rider skills training and a "Share the Road" campaign to improve car drivers' awareness of molorcycles.

Halkyard, who has been teaching the class around the state since July, says any motocycle rider — even the most experienced — can learn something about motorcycle safety by taking the class. "Most of the riders who go through the course have anywhere from three to 30 years of experience on motorcycles," he says, "and I haven't had a person that's been dissatisfied yet."

The local class will be limited to 16 students, and re-class registration is required. The cost of the class is \$10.

A student must provide a motorcycle and proof of ownership, motorcycle endorsement and insurance, Students must wear gloves, over-the-ankle boots, long pants and long-sleeved shirts. Helmets are required and will be provided.

#### Instructor Standards

In order to teach at a  $\underline{\text{TEAM OREGON}}$  training site, the following OTSC approved standards for instructors must be met:

- Instructors must be experienced motorcyclists who currently possess a valid drivers license endorsed for motorcycle operation.
- Instructor candidates must be sponsored by an OTSC-certified training site.
- 3. Instructors must have successfully completed a 60-hour OTSC approved Instructor Preparation Workshop, which includes the following requirements:
  - (a) Complete an MRC prior to attending the workshop, or be able to demonstrate familiarity with the skills, methods, and materials used in the course.
  - (b) Pass a qualifying skill test.
  - (c) Pass a written knowledge test.
  - (d) Pass a student teaching phase of the course.
  - (e) Possess a satisfactory driving record for a minimum of three years immediately prior to approval.
- To maintain status as an active OTSC-certified instructor, an instructor shall:
  - (a) Teach a minimum of four rider education courses (MRC and/or BBP, at least one of each) every three years.
  - (b) Attend one OTSC-approved instructor update workshop every three years.
  - (c) Correctly use OTSC curriculum and guidelines for all rider education programs.
  - (d) Comply with OTSC policies and procedures.
  - (e) Maintain a satisfactory driving record (See OAR Chapter 581, Div. 54, Department of Education, Table I).
  - (f) Model appropriate safe riding behaviors and wear the proper protective clothing while teaching: helmets, gloves, boots, long-sleeved shirt or jacket, long pants, and eye protection.

## Cyclist killed; passenger hurt

Deputies said Young was eastbound on Halsey when he attempted to turn north onto 146th Avenue. His truck collided with Watson's motorcycle, which was westbound on Halsey Street, deputies said. No citations were issued, and an investigation was continuing.

## **Motorcyclist dies** after hitting pole



### Noise for safety

To the Editor: The recent decision by the state Department of Environmental Quality to start sound testing of motorcycles in the Tri-County area is just another political move to develop another source of revenue toward this unenforceable cause.

It is with concern that I have witnessed owners of automobiles adjusting them to pass the emissions test of the DEQ only to adjust them again after passing this test to run as dirty as usual.

I have a non-stock exhaust system on my motorcycle, and its emissions are as clean as those of the stock system. This system is slightly louder than the stock one, but I feel that for safety's sake being heard is at least as important as being seen. This is a small price, considering the cost of medical bills at the hands of some errant driver.

If I must put a stock exhaust system back on my motorcycle, then I shall do so to pass this test. For my own safety, I will no doubt replace it after the sound test with my preferred exhaust system.

The enforceability of such laws is being challenged at every DEQ testing station by the public when such adjustments render the setting useless and unproductive, except for the revenue raised.




