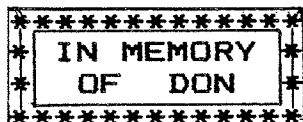

I'd like to point out that Brian Stovall made a motion (which carried) that the Board waive the requirement that the Newsletter Editor be a Board Member for a period of one year, and reaffirm me as Newsletter Editor. I want you all to know that I'm flattered you think enough of my efforts to keep me on for twelve more months. Thank you very much!

Under old business, the consensus was that each Chapter's Membership Secretary should send all memberships directly to Al Cole, rather than the P.O. Box. Al's address is: 1330 ACORN PARK, EUGENE, OR 97402.

Jackson County's Reps brought up a problem - the way our current membership form is worded, as many people as want to can join ABATE as associate members as long as they list themselves as living at the same address as the one person paying for a full membership. A motion was made and passed that "Family Memberships" be limited to family members living at the same address. There was a

whole lot of discussion on this - Chapter Reps are to have a "revised" membership form with them at the next Board meeting - these will be compared and a decision made about how to best word the application to prevent this problem from recurring.

At the June meeting, nine chapters were placed on probation for failure to do one or more things required of them; they are as follows: KLAMATH FALLS, RIVER CITY, & ST. JOHNS for failure to send in Chapter reports to the newsletter more than two months in a row; BEND, CENTRAL OREGON, NE PORTLAND, RIVER CITY, DOUGLAS COUNTY, and WEST PORTLAND for failure to have their quarterly treasurer's report in on time, and EMERALD VALLEY for failure to have twice-monthly communications with the State Coordinator. At this time, probation is lifted on all the above chapters EXCEPT Emerald Valley, as they have complied and corrected the reasons they were placed on probation.

In July, we will be changing the way in which the Newsletter is mailed out to members. The board decided to have a firm called AD-MAIL take care of printing & applying mailing labels, then sorting, bundling, tying, bagging, and getting it to the Post Office. The main advantages are "turn-around" time - 24 hours in most cases, and the fact that we won't have to depend on one or two people to handle it each month. The burden will be on the Editor to get the newsletter printed and to AD-MAIL each month - I hope to have it in the mail no later than the 3rd or 4th of each month. After set-up, the monthly cost will be about \$35 a month - more if we correct the mailing list each month. Here's hoping it works out!

That's about all I have for this month - a complete report will be mailed to all Reps shortly. The JULY MEETING WILL BE AT MOBY DICK'S RESTAURANT IN NEWPORT, SATURDAY, JULY 14th. See you there!

Animal's Corner

FROM ABATE
OF INDIANA

The other day I was listening to the radio and heard an ad by Honda promoting one of their new models. I don't remember which one, but I remember the major point of the commercial was the bike was as fast as thought, 0 to 50 in 2.2 seconds. This made me remember back to 1969 and my first bike, a 250 Suzuki and my first riding experience. I'd stalled the bike a couple of times because I didn't bring the rpm's up enough. Well, I really revved it up, let go of the clutch too fast, and immediately stood the bike on its rear wheel, screamed across the street and buried the thing in our neighbor's evergreen bushes. She was not very impressed. I learned something, you can't steer too well with the front wheel up in the air.

The little Suzuki died horribly about a month later but it taught me a lot and I still sport a few scars from the lessons. I lie about how I got them but that's another story. It seems back then, most all of my friends and I learned riding the same way. We got small bikes and fell down a lot. Eventually the periods between falling down became longer.

Hey man, we were riding!! As addiction to the sport grew, we got bigger and faster bikes. We knew pretty much how not to fall over, but the Beezers and Triumphs were fast. This brought on more education; lean angles, speed into corners, stopping distances, and a few more scars. Some friends who didn't learn their lessons well aren't around today. In the era I grew up in and learned about riding, there were no real production racing machines affordable to the general public.

You generally started small and worked your way up as your experience and monetary supply grew. That is not so today. Now your basic barely over puberty high schooler can get dad to buy him an eleven second street machine for a mere pittance.

The dealer doesn't want to know if he can control the machine, he wants to know if you really have the bucks. Most of the current advertising towards motorcycles is geared to speed. I subscribe to several "General" bike magazines, there are bikes out there, extremely affordable with top speeds of 160 mph and more! But who is buying these machines? The experienced rider dedicated to the sport or the high school kid with overactive glands? I know of one from out west who impressed the Harley riders with a real display of macho and horsepower. He drove his 1000 Kaw into a house at about 120 mph. He also had a bike as fast as thought, but when you don't have experience in handling a bike, what do you think about when you're in trouble?

You don't know what to do next. Maybe if you had the sense you wouldn't be in that situation. The thing is, motorcycle education has not even come close to keeping up with the technology that builds these speed demons. So where does that leave us? We're supposed to be an educational group. That puts the ball in our court. When talking with a friend about another super bike, he asked why anyone would build a production bike that fast. I could only answer "to kill inexperienced riders."

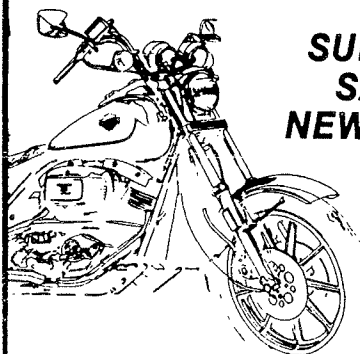

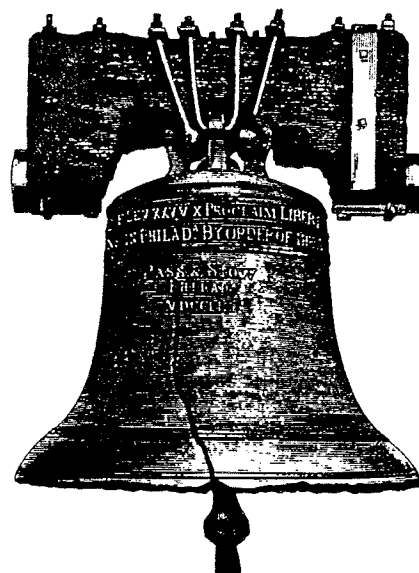

** SOME THOUGHTS ON FREEDOM **

Two hundred eight years ago, a few people, tired of being dictated to by a government that was remote and unresponsive, declared themselves independent of that government. Between the years 1775 and 1783 over 25,000 out of 184,000 to 250,000 Americans died in the struggle to bring an idea to life. To put those numbers in some perspective, there were 407,316 Americans killed between December 7, 1941 and December 31, 1946 - the period known as World War II.

The point of mentioning these figures is that we in this country enjoy an unusual amount of freedom, given mankind's penchant for grabbing as much power and enslaving as many people as possible. True, we are all enslaved to a certain degree, inasmuch as we pay taxes under threat of losing everything we own AND our freedom (highway robbery, IRS style). But the fact that I CAN be critical of the IRS, indeed, the entire U.S. Government, and print my feelings in this newsletter, is something to sit back and think about. In virtually any country ruled by a Socialistic form of government, I'd be in stir by now, and most of you, sitting there reading what I think, would be with me (guilt by association - something that we already have to fight, but that's fodder for a future editorial).

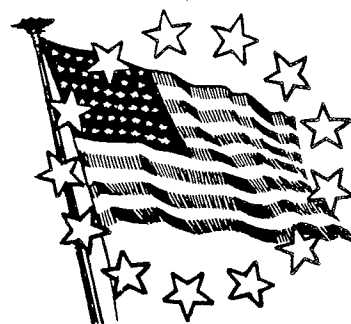

As space permits, I'll try to have a few riding tips in future newsletters. I want to thank Dennis Jones and Terry Butler for caring enough to bring a quality program to Missouri. Also I would like to thank each member of F.O.R.R. for sending me there. And remember, keep an open mind on this. Keep your attitude private, everyone has plenty of their own. Controlling Inflation or What You Should Know About Tire Pressure

Dunlop, a major motorcycle tire producer, is concerned with the way cyclists use and maintain their tires, particularly tires fitted to touring motorcycles. In 1983, our technical personnel attended touring rallies throughout North America to collect vital data and give instructional seminars. Surprisingly, we found that many touring riders were not following proper tire maintenance procedures.

HOW TO KEEP 'EM ROLLING

Maintaining tires properly is not complicated, but does require consistent attention. Vehicle loading should be closely monitored. This ensures that the motorcycle remains within recommended maximum load requirements and that the tires are properly inflated. The basic load and pressure information is clearly stamped on the tire sidewalls. Always keep in mind that the tire does not support the load, rather, the air pressure does. The manufacturer's ratings for the maximum load and inflation pressure are critical tire design elements. If these ratings are not observed, the handling and performance of your motorcycle will be greatly affected.

We checked inflation pressures at several touring rallies last year (e.g., Aspenade in New York). Surprisingly, 70.5 percent of the rear tires inspected were underinflated, some as much as 24 pounds per square inch (psi) less than the motorcycle manufacturer's recommendation. In addition, a weight check performed at a Gold Wing rally in Watkins Glen, New York, showed that 38 percent of the rear tires were loaded beyond maximum tire capacity. Many more

were underinflated. And it should be noted that this situation existed for all makes of tires, not just the Dunlop brand. Regardless of make, underinflated or overloaded tires can cause handling and steering difficulty. This abuse could also cause premature tire wear and catastrophic tire failure.

Adding accessories and/or cargo to touring motorcycles or carrying a passenger aggravates the problem. Excessive tire flexing, resulting from underinflation or overload, causes internal heat build-up, cracking and eventual tire failure. Stress cracks in the tread indicate an overloaded and/or underinflated condition. If you find evidence of tread cracking, you should remove and replace the tire immediately. This damage is *permanent and non-repairable*. In addition, uneven wear may also result from using underinflated tires.

Using trailers may also contribute to tire damage and machine instability. The trailer "tongue weight" (i.e., the weight transferred to the rear of the motorcycle as a result of pulling a trailer) added to a heavily laden motorcycle can cause a rear tire to fail. Rapid acceleration and deceleration may also multiply the effects of trailer tongue weight.

Follow these tire inflation guidelines when loading touring motorcycles. For a single rider (total combined load of rider and luggage equals up to 200 pounds), maintain minimum tire pressures of 32 psi front and 36 psi rear. For dual riding (total combined load of rider, passenger and luggage equals over 200 pounds and up to the maximum motorcycle capacity stated in the owner's manual), maintain pressures of 34 psi front and 40 psi rear.

Always learn to recognize tire warning signs. For example, if the steering response is slow or mushy, or if cornering and braking response is heavy, there's a good chance your tires are underinflated. Vibration or wobble may signal that actual tire damage has occurred.

Following these recommendations ensures that you'll enjoy longer and safer tire performance.

Tire Points to Remember

To get the maximum safe use from tires you should:

- Properly maintain your vehicle in accordance with manufacturer's recommendations;
- *Never* exceed the loading and accessories restrictions of your bike or the maximum load displayed on the tire sidewalls, and know the loaded vehicle weight;
- Check air pressure at frequent, regular intervals, particularly before and during long trips;
- *Always* use an accurate tire gauge and check pressures only when the tires are cold (i.e., wait one hour after running). NOTE—a tire gauge that holds a reading is preferred;
- Inspect tires often, looking for irregular wear, signs of cracking in the sidewalls and tread, blisters, knots, cuts or punctures.



Checking your tires before each ride can help avoid an underinflated or overloaded condition. When inflating tires, always follow the motorcycle manufacturer's recommendations.

Motorcycle lights don't reduce accidents

UNIVERSITY PARK, Pa. — Use of motorcycle headlights during daytime riding has little or no effect on preventing fatal multivehicle collisions, concludes a study by a Pennsylvania State University researcher. Andreas Muller, a professor of health planning and administration, studied 20,000 motorcycle deaths in 46 states and the District of Columbia from 1976 through 1981. In California — which in 1978 required all new motorcycles sold in the state to be equipped with headlights that turn on automatically when the engine is started — Muller found there was no significant decrease in the number of daytime accidents. Similar results were found in the other locations studied.

Hells Angel To Carry Olympic Torch

Thanks to \$3,000 raised by members of the Hells Angels motorcycle club and a ruling from the Los Angeles Olympic Organizing Committee, George (Gus) Christie, 37, the president of the Ventura, Calif., club chapter, will run a leg of the national Olympic Torch relay.

Christie said he won't be carrying the leather and chains the club is known for, but he will wear his silver skull earring and a running cap identifying himself as an Angel.

The Angels collected \$3,000 from its members nationwide.

"There have been rumors we were going to disrupt the Olympics or something," said Christie. "So, we decided we'd get out in front as supporters."

Christie received an acceptance letter from Olympic Torch relay official Joel Fishman.

But Olympic Organizing Committee officials reacted differently at first. Christie's check bore only his name and the letters H.A.M.C.U.S.

"I had no idea what that was," said committee spokesman Steve Montiel.

Informed that the acronym stands for Hells Angels Motorcycle Club of the United States, Montiel mulled it, then issued this comment: "Anyone contributing \$3,000 to a youth organization and agreeing to conform to our regulations can participate in the torch relay."

Christie designated the Special Olympics, a national sports program for disabled youngsters, the recipient of the Angels' \$3,000.

- 84** Road widening in Sandy River-Mitchell Point area. One-lane closures anticipated. Traffic controlled by signs and flaggers.
- 84** Paving work between South Baker and Durkee interchanges. Some slowdowns expected. Traffic controlled by flaggers.
- 26** Road improvement work between Dayville and Flat Creek. Some blasting in progress. Minor delays anticipated. Traffic controlled by signs, flaggers and pilot car.
- 97** Grading work in Lava Butte-Fremont Junction area, north of La Pine. Minor delays. Traffic controlled by flaggers.
- 101** Reconstruction work on Yaquina Bay Bridge in Newport. Minor delays. One-way traffic controlled by flaggers and pilot car from 8 a.m. Mondays through noon Fridays.
- 101** Slide reconstruction at Frankport area, 15 miles south of Port Orford. Possible delays. Part of section is undergoing gravel resurfacing.



California

* GUIDELINES FOR FLIERS *

I realize that this is a bit late into the run season, but late is better than never. I hope those of you responsible for drawing up your chapter's run fliers will follow the guidelines below - they apply to the fliers you hand out as well as those that appear in the newsletter:

- 1) Try to make your message as brief and to the point as possible. Many fliers are thrown away unread because they look too "busy". Keep in mind that I generally reduce fliers to 1/4 size, and that has the effect of "cramming" things together. Give a phone number to call for more information, rather than trying to cram everything in.
- 2) Vertical format, rather than horizontal, is preferred. Compare the current fliers with the Screaming Eagles flier; the vertical format reduces best.
- 3) Allow at least 1/8" margin of blank paper on all four side of the flier.
- 4) Maps are great, but I'd really prefer to have a flier with a map as two separate sheets of paper; it's easier for me to copy and reduce them if I do not have to worry about something on the back side of the "master" showing thru in the "copy".
- 5) Please send me copies that are as close to the original as possible; i.e., the "first generation" copy. A copy of a copy of a copy can look awfully bad by the time the newsletter gets printed. Whoever is responsible for drawing up the original flier should send me the very first copy made, and **USE WHITE PAPER FOR THE NEWSLETTER COPY!!** I can't overemphasize this point!! Colored paper "originals" do funny things in the photocopier - so use white paper (for me) only!!
- 6) Avoid using "banner" style headlines that consist of white letters surrounded by a black background - they reproduce and reduce poorly and require extra work to "clean-up" for printing.
- 7) There is **NO ADMISSION CHARGED** at any run that's sanctioned by ABATE! Surprised? We are a "non-profit" organization, therefore, we can only ask for "donations". Please make sure your fliers use the word "DONATION".
