# Cyclist fatalities on rise

East Multnomah County authorities say hot weather and novice or careless motorcycle riders have led to a dramatic increase in the number of motorcycle fatalities and injuries this summer

Many victims have had limited riding experience, said Bob Schmidt, who investigates accidents involving deaths or serious injuries for the Multnomah County sheriff's department. He said the combination of "fair-weather riders" and "hot-weather drinking and exuberance" had led to more fatalities this year, many involving young people and people who do not wear state-approved helmets.

Motorcycle fatalities statewide have increased more than 50 percent over previous summers, according to statistics from the state Motor Vehicles Division. From May through July 1984, there were 21 motorcycle-related deaths reported statewide. This year, in the same three-month period, the number of fatalities climbed to 32.

Although it is legal for people over 18 to ride a motorcycle without a helmet, police said that riding without head protection was dangerous.

"Injuries have been on the increase, statewide and locally, because those involved have not worn the proper protective gear," said Lt. James Gruetzke of the Gresham Police Department.

Gruetzke's point is illustrated by the recent case of Joe Russell, a Gresham High School senior who fell from a motorcycle driven by fellow student Brett Logan, near the corner of East Burnside Road and Main Avenue on Aug. 12. Russell, a state wrestling champion, received serious head injuries and immediate surgery was required to remove skull fragments that had become lodged in his brain. He was not wearing a helmet when the accident occurred.

In the state's most recent motor-cycle fatality on Aug. 12, Carl T. Fraly, 15, of Boring died when he drove his motorcycle into an oncoming car on Southeast 262nd Avenue. Fraly was driving the motorcycle illegally, without a license or learner's permit, according to Deputy Russ Williams, public affairs officer for the Clackamas County sheriff's office.

The speedometer on the wrecked motorcycle was stuck at 60 mph, indicating that Fraly probably lost control of it while speeding, Williams said.

Although Fraly was wearing a helmet, Williams said, it was not a helmet designed to withstand heavy impact. The helmet had no front protective shield. It shattered on impact.

Maury Wilson of the Oregon Traffic Safety Commission said he had seen an increasing number of people this summer riding motorcycles in shorts and without helmets. Without protective gear, he said, "The chances of not being injured are very remote."

At least 84 percent of all the injuries resulting from motorcycle accidents are head injuries, according to Sgt. Al Akers of the Portland Police Bureau's traffic unit.

Lower prices and easier financing on motorcycles and motor scooters have led to a greater number of inexperienced riders on the road, Akers said. These newer riders don't always know how to handle their motorcycles in emergency situations.

Vinita Howard, information officer for the state Motor Vehicles Division, said that most motorcycle accidents were not the fault of the motorcyclist, but of another driver, so good defensive driving skills were critical to a cyclist's safety. Often, Howard said, the car driver simply does not see the motorcycle. In the most common motorcycle accident scenario, a car makes a left turn in front of an oncoming cycle.

"The drivers of other vehicles need to be more alert and the cyclist needs to be aware that he can't be seen," Howard said.


