HEPATITIS ALERT

The State Health Division has been notified by the Portland metropolitan area counties (Multnomah, Washington, Clackamas) that several cases of hepatitis type A have been reported to their health departments in members of the ABATE motorcycle lobby group. All of the current cases attended a rally over the Memorial Day weekend at Shelton Wayside near Fossil, Oregon. We are unable to pinpoint a particular food item common to all cases, and the water system has been tested by the EPA and tests clean. Because all of the cases did attend this rally, we would like all members, but especially those who attended the rally, to be aware that they may have been exposed to hepatitis A. If a person develops symptoms of hepatitis they should seek advice and medical attention at their private physicians or the county health department.

Symptoms of hepatitis may include fever, chills, loss of appetite, nausea, vomiting, excessive fatigue, pain in the right upper abdomen, dark urine, light colored stools, and yellowing of the skin or eyes (jaundice). Mild hepatitis may not include all these but may be described as "flu-like" illness. Some persons, especially children, have no symptoms at all. A person may develop hepatitis anywhere from 2 to 6 weeks after exposure.

Because hepatitis A is spread by feces of one person being ingested by another, extremely good personal hygiene is very important. Wash your hands very well after using the bathroom, before eating or preparing food, after diaper changing, or before handling anything which another person will put in their mouth.

Please notify your county health department if you do develop symptoms.


