HELP! HELP!

WE (A.B.A.T.E.) need AD's for this <u>OUR</u> Newsletter. With out these <u>paying</u> AD's, all we are doing is breaking even. If we don't get more <u>paying</u> AD's, we are going to lose our shirt's. So go out and sell some AD's, <u>PLEASE</u>.

## **BBP UPDATE**

I suppose everybody wonders if the Mobile Better Biking Program fell through the floorboards! Not so – it just seems that every time I turn around, I've missed another newsletter deadline.

During 1985, we conducted ten Mobile BBP's training a total of 122 students, and one Mobile MRC (beginning Motorcycle Rider Course) with 9 graduates.

**NEW INSTRUCTORS** Joining Ed Halkyard and LeRoy Hecker as MSF/Team Oregon certified instructors, Jim Dodson and Stephen Perry were trained this year. Also joining the Mobile staff was John Goff, an at-large ABATE member who is also the newly-elected president of AMA District 28. When the season really got busy, other Team Oregon instructors helped with some classes: were Joel Fredericks (Eurosport), Earl Nash (Site Coordinator at Clackamas Community College), and Scott Lewis (Klamath Falls).

**AWARDS PRESENTED** When Team Oregon held its annual Recognition Banquet at Corvallis in November, the quality and dedication shown by our program instructors received some well-deserved special recognition: Ed Halkyard (of Douglas County Chapter) was named "Instructor of the Year." LeRoy Hecker, of Emerald Valley Chapter and a member of the Free Souls, was awarded for "Outstanding BBP Effort." (LeRoy was responsible for training 99 students just this year, outdistancing Ed by 2 students.) John Goff was named "Rookie of the Year," teaching not only for the Mobile Program and Clackamas CC but also for Washington State's Motorcycle Safety Program. CONORATULATIONS, Y'ALL DID A FINE JOB!

During Nevember and December, we entered into negotiations with the Oregon Traffic Safety Commission for a 1986 contract. At this writing, these negotiations are incomplete.

FUTURE CHANGES During late 1985, we have been working with the ABATE BBP Advisory Committee toward setting up a new, tax exempt structure for the Mobile BBP. This involves incorporation as a non-profit Oregon corporation, separate from ABATE of Oregon, Inc., and applying for tax-exempt status with the IRS. If the tax-exempt status is granted, the Mobile Program (under a new name) will be an educational organization, funded from various sources. The new organization would not be allowed to conduct any political activities. No BBP employee or relative would be eligible to serve on the Board of Directors of the new organization. This is also still in the development stage at the time of this writing. The reasons behind this plan to separate from ABATE include: to simplify the tax reporting procedure for both ABATE and the Mobile Program, and ease the load on the State Treasurer; to allow the Mobile Program to seek funding grants from private corporations (who will donate only to tax-exempt organizations); and to allow the Program to apply for a cheaper bulk mailing permit which has been denied ABATE.

WE STILL NEED MORE ABATE INSTRUCTORS As you have all seen by the ad that ran in the ABATE newsletter most of this year, we are looking for more ABATE members to be trained as motorcycle safety instructors. Team Oregon needs many new instructors during the next two years, in all areas of the state. ABATE NEEDS REPRESENTATION IN THIS FIELD! It's part-time work, which in most cases can be fit in with a regular 5-day-a-week job. Several different Instructor Preparation workshops, on different schedules, will be conducted in 1986 - and one of them might be right for you. If you are interested, please write or call me, or talk to one of the instructors for more information.

**RESERVE A DATE FOR NEXT YEAR'S BBP** If your chapter wants to conduct a BBP in 1986, and has not yet talked to me about scheduling, please do so right away! It is time to get the '86 schedule together. Just like the ABATE run calendar, it's First Come, First Served. We encourage scheduling classes in spring and early summer, any time after April 1, so riders can get maximum benefit from the experience. The time to polish up skills is at the beginning of the season – and besides, a class in the middle of summer can get downright painful for both body and machine, since there is rarely any shade in the middle of an asphalt parking lot. We will schedule classes through the end of October, but want to emphasise that new skills learned at the end of the riding season will not be retained as well because they will not be used as much before the snow falls and we have to pack it away again.





## \* <u>GUIDELINES FOR FLIERS</u> \*

As winter approaches once again, I felt it would be useful to re-run this article. I hope those of you responsible for drawing up your chapter's run fliers will follow the guidelines below - they apply to the fliers you hand out as well as those that appear in the newsletter:

- 1) Try to make your message as brief and to the point as possible. Many fliers are thrown away unread because they look too "busy". Keep in mind that I generally reduce fliers to 1/4 size, which has the effect of "cramming" things together. Give a phone number to call for more information, rather than trying to cram everything in.
- 2) Vertical format, rather than horizontal, is preferred.
- 3) Allow at least 1/4" of blank paper on all four sides of the page.
- 4) Maps are great on the back of the hand-out fliers, but when you include a map for the newsletter, please do so on a separate sheet of paper. It's easier for me to copy and reduce them if I don't have to worry about something on the back side of the "master" showing thru in the "copy".
- 5) Please send me copys that are as close to the original as possible; i.e. the "first generation" copy. A copy of a copy of a copy can look awfully bad by the time the newsletter gets printed. Whoever is responsible for drawing up the original flier should send me the very first copy made, and USE WHITE PAPER FOR THE NEWSLETTER COPY! I can't emphasize this point too much!! Colored paper "originals" do funny things in the photocopier so use white paper (for me) only!!
- 6) Avoid using "banner" style headlines that consist of white letters surrounded by a black background they reproduce and reduce poorly & require extra work to "clean-up" for printing.
- 7) There is NO ADMISSION CHARGED at any run sanctioned by ABATE of Oregon! Surprised? We are a "non-profit" organization, therefore, we can only ask for "donations". Please make sure your fliers use the word "DONATION". Also, please refrain from using the word "beer". Substitute "BEVERAGES".
- 8) Please try to have flyers to the Newsletter at least 60 days in advance of your run date. This is your Newsletter take advantage of it in order to reach as many people as possible.

I hope this will be of some help to you when it comes time for you to prepare the flier for your run. I also want you to know that I don't mean you shouldn't use colored paper for the fliers you hand out at meetings — it's just that I need white paper to make copies from. If you make up a flier and ask members to make copies, make sure THEY get their "master" copy on white paper as well. Thanks!



## WHAT SHOULD I DO IF I GO DOWN

This article is the first in a continuing series to inform all bikers of their legal rights. Every month we will attempt to give you information to help protect you, no matter where you ride.

The most serious problem bikers have to deal with is the inevitable traffic accident. Approximately 70% of all multivehicle accidents involving a motorcycle is not the biker's fault. The following will help you protect your rights and answer the question: What Should I Do If I Go Down?

## INFORMATION TO GET IMMEDIATELY

- 1) Witnesses: This is listed first, for they will disappear the fastest (especially due to the public's fear of bikers). Try and get some sort of identification so they might be contacted later: name, address, phone number, license plate number, where they work, etc.
- 2) Other Driver: All traditional information is needed: name, address, phone number (at both home and work), driver's license, make/model/color and license number of vehicle. In addition a very helpful piece of information is the insurance carrier of the driver of the cage. If this is not obtained and if the other driver does not respond to letters sent by your attorney, you will find that most states require long waiting periods before supplying the necessary information to pursue your case that means recovery for your injury could be delayed. One final thing. Listen to and memorize statements made by the other driver. These statements (also known as admissions) may be used as evidence in many states. An example of this would be the driver of a left turning cage saying; "I didn't see you". His statement could be used to prove the accident was his fault. NOTE: Remember this also works in reverse. Anything you say can also be used against you.

### POLICE REPORT

Although most of what is recorded in a police report cannot be used in court, it is a great negotiating tool. Keep in mind that most personal injury cases are settled rather than go to trial. A favorable police report can be instrumental in bringing you a quick and generous recovery for your injuries. As we all know, cops can be a mixed bag. However, (in an accident situation), I have found most police to be fair in their assessment of fault. This is especially true of the motorcycle cop.

## INJURIES

This is not the time to show how macho you are. After the actual collision take a few minutes to check yourself out. The initial shock may numb you as to how injured you really are. Remember, the human body is not made to be bounced off the ground. It is a good idea, (and will aid in showing the validity of your case), to get checked out at the local emergency room (hospital) or by your own doctor. Be sure to explain all your pains to the doctor so he or she can make a complete evaluation and treat you appropriately

for the injuries.

## NO STATEMENTS

When you are contacted by the insurance company, (which is usually immediately - even right at your hospital bed), tell the adjuster you don't wish to give a statement at that time. Even if your statement seems favorable to you, the insurance company would have lots of time to pick out the flaws. Keep in mind that the adjuster's job is to save the insurance company money, and therefore any money offered as a "fair settlement" will usually only be fair to the company.

## CALL A PERSONAL INJURY ATTORNEY

The first twenty-four hours after an accident is crucial for your case. An immediate investigation should be started, including photographs showing your injuries, the accident scene and the involved vehicles. Statements from witnesses and the other driver should be gotten as soon as possible. The police report should be requested and an inspection of the point of impact for skid marks and other material evidence should be made. You will notice that I advised you to call an attorney who specializes in personal injury. The law, as with medicine, is highly specialized, and you are entitled to be represented by an attorney who is best qualified to obtain a maximum recovery for your damages. A quick call to the attorney entitles you to the following services:

- 1) Protection from insurance company employees the magic words are "I am represented by counsel and don't wish to make a statement."
- 2) A "house call" if you are unable to go to the office.
- 3) Immediate investigation of your claim.
- 4) The possibility that your scooter will be fixed prior to the settlement of your injuries and a rented vehicle while you wait.
- 5) The evaluation and protection of your legal rights.


