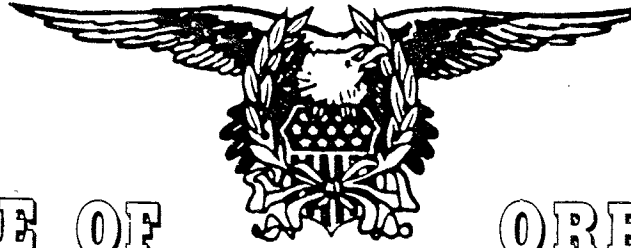

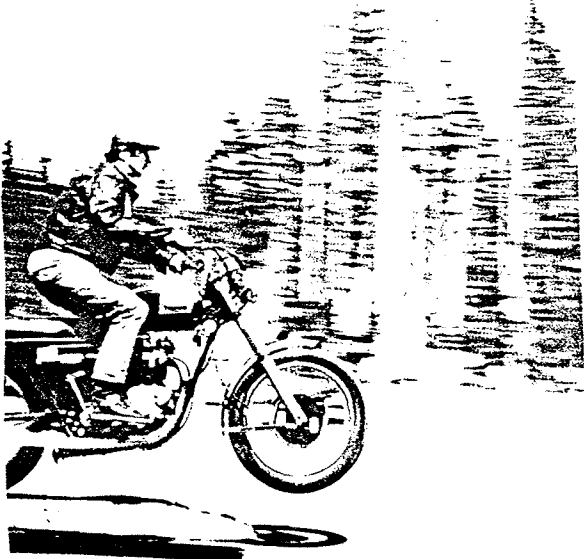
River City

Biker helmet law doffed again

Larry Stone got a provincial court judge to agree Thursday that he can ride his Harley Davidson motorcycle without a helmet.

But that didn't deter police from ticketing him minutes after he left the courthouse.

"The judge's ruling just happened, so the cops haven't got the word yet and are still giving out tickets," the 38-year-old Stone said later. "But I'll be riding without a helmet now."

Stone was riding home from Vancouver provincial court Thursday afternoon following a ruling by Judge Wallace Craig that Section 218 of the Motor Vehicles Act, which dictates motorcyclists must wear helmets, is invalid.

Stone was fighting tickets issued in February for wearing a helmet that did not meet provincial standards.

Craig's ruling marked the sixth time in the last eight years compulsory helmet legislation has been ruled invalid.

Craig ruled the act invalid because it gives the superintendent of motor vehicles power to set standards for helmets, which is beyond his powers since non-elected government employees are only supposed to administer legislation.

The ruling frustrates amendments to the Motor Vehicles Act introduced less than six months ago to keep the act from conflicting with a Nov. 25 ruling that B.C.'s helmet laws violated the Charter of Rights because they did not define a safety helmet.

Stone says Craig's decision means greater safety for motorcyclists.

Corp. David Aitken, of the Vancouver police, said his own experience in dealing with traffic accidents has shown motorcycle helmets are vital.

1,000 bikers visit Seaside

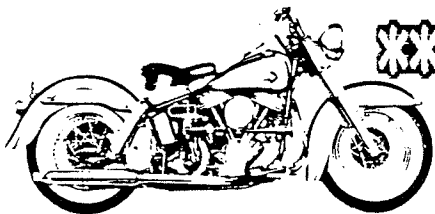
SEASIDE — More than 1,000 motorcyclists were in Seaside Saturday to promote a benefit ride to raise money for diabetes sufferers.

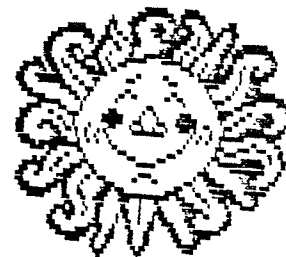

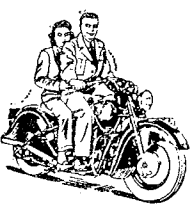

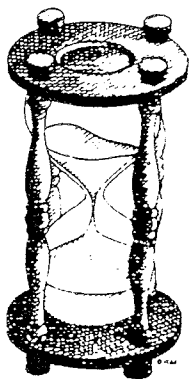
