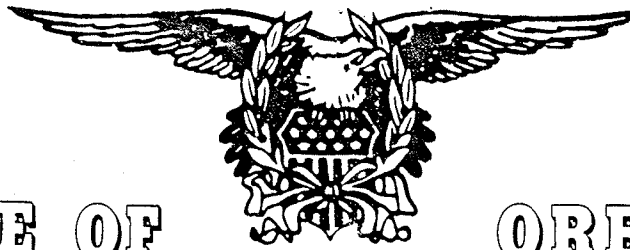

Rules of Operation up-date:

Article I -- Office:

I. The principal office of A.B.A.T.E. of Oregon Inc. for the transaction of it's business is located at P.O.Box 4504, Portland, Oregon, County of Multnomah, State of Oregon.

Article III -- Directors:

6. Representatives shall receive no compensation for their services as Board members, but may be allowed transportation expenses to attend Board meetings. Such money should come from the Chapter Treasuries. State Board Officers may receive transportation expenses from the State Treasury if the Chapter is unable to pay it, and if accompanied by filled out expense sheet.

Article IV -- State Board Officers:

7. The Treasurer shall keep a running Cash Journal on all financial transactions made by A.B.A.T.E. of Oregon Inc. He/she shall deposit funds into the corporation account's; with-drawals from corporation funds shall be made by check signed by the Treasurer and one other Officer, that Officer to be designated by the Board of Directors. Transfer's from Savings Account to Checking Account, will be made by Treasurer. He/she shall perform all duties incidental to the office and such duties as may be required by law and the Articles of Incorporation or by these Rules. That a review of our financial books be done by a qualified person or agency, at least annually.

8. The Membership Secretary will send out membership cards and membership information, he/she has one month from receipt of application, to send out this information. The Membership Secretary will deposit Membership funds only. The Membership Secretary will provide monthly a total membership list for the State Coordinator, and monthly up-dated membership address labels for the Newsletter Editor.

He/she will prepare a monthly up-dated membership list for each Chapter Membership Secretary. He/she shall provide New Membership packets, including all items necessary and ancillary to being a member. The Membership Secretary is to provide information to anyone wanting to start a New Chapter.

11. The Legislative Director shall be responsible for coordinating and communicating legislative information and legislative activities. He/she shall be responsible for coordination between A.B.A.T.E. of Oregon Inc. and the Motorcycle Safety Coordinator for the State of Oregon, the above job duties are subject to control of the Board of Directors. The Legislative Director may be a Lobbyist or if the need be, may be assisted by an appointed Lobbyist. Between Board meetings the Coordinator shall act as the Lobbyist's supervisor. Activities by the Lobbyist out-side his/her defined duties shall be considered the acts of the individual and not of the Corporation.

RULES for LOBBYIST: 1) Lobbyist will be required to register with the Oregon Government Ethics Commission and to file a quarterly expenditure report with them. A copy of this report in it's entirety to be filled with A.B.A.T.E. 2) Lobbyist will be required to keep a trip log book with the following information A) All trips made on behalf of A.B.A.T.E. 1) Dates 2) Miles to and from 3) All meals during trip. B) Any and ALL expenditures for government Official's or their Aid's 1) Coffee, meals gifts, etc. At the end of the year, the log will be turned over to A.B.A.T.E. to be held in it's files. When requesting reimbursements from the treasury, receipts will match the log.
