LEGISLATIVE ISSUES:

On January 12th, 1987 the 64th OREGON LEGISLATIVE ASSEMBLY began its 1987 Regular Session in Salem. 1-800-332-2313 is the number for Legislative update information.

As of this point in time (1-25-87) there has not been a HELEMET Bill introduced. Senate Bill (S.B.) 87 has to do with a mandatory seat belt law for everyone - more on this next month - when I have more information on it (S.B. 87).

Below is a break down on the first three (3) bill's that A.B.A.T.E. of Oregon, Inc. will be supporting this legislative season.

House Bill (H.B.) 2160 and H.B. 2161 were filed at the request of Traffic Safety Commission, and Governor's Motorcycle Safety Advisory Committee. A.B.A.T.E. of Oregon Inc. has a VOICE on the GMSAC - Yea Teresa ! ! !

Oregon Revised Statute (O.R.S.) 807.170 read's in part, upon original issuance and renewal of motorcycle indorsements a fee of \$2 will go to the Motorcycle Safety Sub-account. H.B. 2160 will raise the ammount to \$3, not \$2. The extra \$1 will go the Motorcycle Safety Sub-account also.

H.B. 2161 is for the first time placing a \$3 fee on moped indorsements - the \$3 will go into the Motorcycle Safety Sub-account - just like O.R.S. 807.170.

H.B. 2210 was filled at the request of Joint Interm Committee on Transportation. From reading through this bill, it is going through 13 old laws and dotting all the eyes and crossing all the T's and making some of the passages more readable and understandable.

There is a section that deals with the Fuel Conservation Maximum Speed Limit. A change on page 5 of this bill is most interesting. How does this sound ? - if a person commit's the offense of violation of the Fuel Conservation Maximum Speed Limit and if the State has a law (yes we do - 810.180) making it illegal - now this is the good part - O.R.S. 811.110 reads in part - in NO event shall the division suspend or revoke a persons driving privileges in this State solely on the grounds that the person has incurred one or more convictions of a violation of the Fuel Conservation Maximum Speed Limit. Interesting no - we can't lose our driving privilages for over 55 mph tickets, it would still be a class C traffic infraction.

O.R.S. 811.180 could possibly make a driving while suspended or revoked defense a little, to a lot easier. The judge can take into account if there was an emergancy or some other very important reason, for your having to drive.

O.R.S. 811.275 is a easy one to explain, it states that a person entering an intersection at an unlawful speed shall forfeit any right of way the person would otherwise have had. In easy to understand words - if you are speeding when you have the right of way - you think - you don't.

Now to O.R.S. 814.200 - they are trying to make it more understandable. It would be ammended to read; (1) a person operating a moped or motorcycle commits the offense of unlawful moped or motorcycle operation if the person does any of the following; (a) Fails to set on a permanet and regular seat attached to the moped or motorcycle. (b) Fails to set astride the moped or motorcycle seat facing forward and with one leg on each side of the moped or motorcycle. (c) Carries a package, bundle or other article which prevents the person from keeping both hands on the handlebars. (2) The offense discribed in this section, unlawful moped or motorcycle operation, is a Class B traffic infraction - same as last year.

This section goes on to read - (1) A person commits the offense of unlawfully carrying a passenger on a motorcycle if the person does any of the following; (a) Carries on a motorcycle a person who is not on a permanet and regular seat, if the motorcycle is designed to carry more than one person or upon another seat attached to the motorcycle at the rear or side of the operator's seat. (b) Carries a person in a position that interferes with the operation or control of the motorcycle or the operator's view. (c) Carries a person, other than in a sidecar or inclosed cab, on a motorcycle with no footrests for that person.

Now to moped's and passengers, O.R.S. 814.330 read's - (1) A person commits the offense of carrying a passenger on a moped if the person operates a moped on any highway of this State with a passenger, other than in a sidecar or inclosed cab, on the moped. (2) The offense described in this section, unlawfully carrying a passenger on a moped, is a Class D traffic infraction.

You the members can H E L P by writing your elected reps and VOICING your support of H.B. 2060, H.B. 2061 and H.B. 2210. If WE (you and I) don't tell these people that WE would like to see thes House Bills pass, no one else will, don't delay, do it now.

NCOM: has other organizations, Legislative info and strategy, federal lobbyist, grant and loan money, newspaper, public awareness tapes that can be custom made for A.B.A.T.E. of Oregon to use as part of a membership drive. Cost to join - free - no cost - no release of your mailing list, no signing of papers to join.

AMA: More Legislative info and strategy, federal lobbyist, referee school and "Insurance for Events" Cost to join AMA is \$20.00 AMA Club Chapter, \$10.00 Ore. Dist. 28 Charter, \$20.00 AMA Sanction - put in national magazines, Free Ore. Dist. 28 Sanction - put on calendar (1st one free - add't \$10.00). Need a Min. of 10 current AMA members, President, Secretary, Club Legislative, Referee and six other club members, \$20 Full membership for indiv. and \$5 AMA Ore. Dist. 28 for indiv. Well it finally happened! After over a decade of lip service to a national coming together of all motorcycle groups to give motorcyclists a strong united national voice, the time has arrived. Long overdue—and stalemated many times by group rivalries, bickering and a lack of finances—The National Coalition of Motorcyclists (NCOM) was formed and is functioning.

On January 27th through 29th, 1986, ten leaders of various motorcycle groups from different states and geographic locations, flew into Las Vegas, Nevada. The mood was positive with attitudes and egos being replaced by agreement on the great need for a national voice to protect our lifestyle and right to ride.

AIM will supply complete financing for NCOC through legal fees (a way to recycle money from motorcycling into motorcycling), and will not accept any outside funding or donations, thus guaranteeing NCOC's absolute neutrality.

All motorcycle groups will be invited to participate, regardless of what they ride, the patch they carry, or the biker rights organizations they belong to. One of the largest voiceless minorities in America is about to speak in one thunderous voice!

The goal and purpose of the National Coalition of Motorcyclists is to assist ALL motorcycle organizations and individual riders with legal, legislative and other motorcycling issues. The new generic coalition will not tell any organization what to do regarding motorcycling issues, but will be available to assist and advise NCOC organization members. The coalition will not get involved in group politics.

AIM, the Board of Advisors and member organizations pledge to initiate and accomplish these services to achieve the goals and purposes of The National Coalition of Motorcyclists.

LEGISLATIVE ASSISTANCE

Information Data Bank:

- (a) Legislative information involving motorcycling will be available to NCOC members at no charge.
- (b) Information regarding products liability, lab tests, statistics, etc., will be available.
- (c) Information will be requested from NCOC members for the data bank which can be shared with other NCOC groups.
- (d) Information to assist in educating NCOC members on how government works at all levels and how to access a particular entity.
- (e) A free newsletter for NCOC members regarding legislative matters and other key issues.

Qualified Legislative Advocates:

- (a) Lobbying for our interests on the federal level.
- (b) Available to go to NCOC member states to assist and advise members on strategy regarding state legislation.

COMMUNICATIONS

Develop a communications "network" among and for all motorcycle groups.

Exchange information regarding motorcycling issues.

Assist NCOC members with geographic NCOC advisors to keep on top of key issues in their area.

Promote NCOC member organizations' meetings or special events via the newsletter.

GRANT PROGRAM

Limited funds will be available to NCOC member organizations for worthwhile motorcycle projects.

PUBLIC RELATIONS/PUBLIC AWARENESS

Develop a nationwide public awareness program (Share the Road, etc.)

Develop and maintain a comprehensive mailing list of all motorcycle organizations and key persons to assist in developing an effective communications network.

Attend key motorcycle-related meetings and events.

Promote motorcycle organizations and key persons to work together for the betterment of motorcycling.

SPECIAL ASSISTANCE

Provide financial and technical "start-up" assistance, regardless of the generic name, to assist in organizing groups where needed.

Assist with rider training and education.

Recognize, understand and assist in solving motorcycling problems before they become major problems for the rider.

Promote unsafe product awareness and lab testing.

STRUCTURE

A Board of Advisors, geographically located across the United States, will:

- (a) Assist NCOC members.
- (b) Be knowledgeable of motorcycling issues in their geographic area and keep the NCOC office informed.
- (c) Assist in market the NCOC and A.I.M.
- (d) Assist in meeting the goals of the NCOC.
- (e) Attend NCOC meetings.
- (f) Assist in hosting and facilitating the national conference each year.

Qualified Legislative Advocates available on an as-needed basis for each member organization.

NATIONAL CONFERENCE

The National Coalition of Motorcyclists will sponsor a national conference each year for the purpose of training and educating NCOC members on key issues; hold meaningful workshops; and, cause an exchange of information critical to all areas of motorcycling.

A.I.M. is very proud to be the financial vehicle for this exciting effort to give voice to one of the largest minorities in the United States. As you can see this is a new chapter in the continuing effort of the Law Offices of Richard M. Lester to help you and every biker.

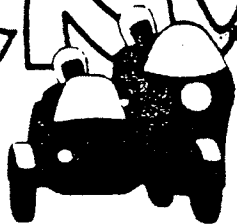

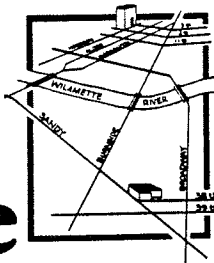

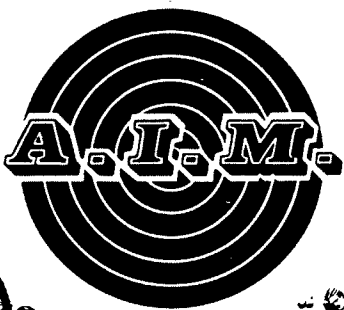

DO'S AND DON'TS OF LETTER WRITING:

Read these helpful hints carefully before you begin to compose your letters to your legislators. These hints will help you to write effective and persuasive letters.

- 1) Open with "Dear Senator" or "Dear Representative".
- 2) Close with "Sincerely".
- 3) Be brief, business like, and specific.
- 4) Be reasonable.
- 5) Support your arguments with examples from your riding, personal or business experience.
- 6) Be yourself.
- 7) Tell exactly where you stand on an issue.
- 8) Be polite (Be nice to him if you expect him to be nice to you).
- 9) Be appreciative of his efforts. ("Thank you for taking time to read my letter", or something of that nature)
- 10) Include your return address.
- 11) Make sure that you spelled all of the words correctly.

No legislator would be impressed by a sloppy letter. If you plan on making a phone call, do the following:

When he answers, give your name, town, and legislative district. State your opinions just as you would in a letter. You should prepare your comments according to the list above so that you get your point across in a convenient amount of time.

You should start your letter writing campaign immediately. Don't put this off until tomorrow. Tomorrow may be too late, and all of the work we have done will be down the drain.

HOW TO CONTACT YOUR LEGISLATORS:

- 1) See who represents you first.

Each district in Oregon has so many legislators, representatives and senators. These legislators know that you vote and you influence the votes of others around you.

REASONS FOR NOT CONTACTING YOUR REPRESENTATIVE AND SENATOR:

- 1) You don't care about helmet laws and rider education programs.
- 2) You're too lazy and would rather sit back and complain.
- 3) You're too busy and have more important things to do.
- 4) You can't afford a 20¢ stamp.
- 5) You're still mad at the phone company because a call now costs 25¢ instead of 10¢.
- 6) You don't know who to write or what to say.
- 7) Other: Please write your excuse below.
