State Board Report

The December State Board meeting was held on the 13th, at the Gatehouse Pizza in N. Springfield, Oregon. The meeting was called to Order at 1:04pm by Deacon. Minutes were read by Mike with no corrections made. There was 26 voting reps. present & all but two State Board Officers were present.

TREASURER REPORT was given by Patty, ask your State Reps. for more info. Patty received a thank you letter from A.B.A.T.E. of Indiana for our donation of \$100 to help defray the cost for the U.S.A.-A.B.A.T.E. conference in October. Patty is also sending out the bills for the extra newsletters that the chapters that have requested for the months of October, November and December.

MEMBERSHIP SEC.: Carolyn stated that as of Dec.1st we have 695 paid members.

We started something new at the December meeting to see if it would help speed up the way the State Board operates during the meetings any faster. We broke down into the first set of sub-committee which consist of Finance,Parliamentary, Newsletter & Paraphernalia. The second sub-committee consist of Fossil & Legislative.

COMMITTEE REPORTS

Finance Committee: Patty; they made two motions first to assessed a 10% late charge on chapters that don't pay for their extra newsletters if not received by the 30th of the month following the sending out of the bill. The second motion was to allocate Butch & Dr. Dave \$190 to attend education classes in Salem.

Parliamentary Committee: Dr. Dave; they made one motion for the chapters and State Coordinator to gather all information for that they can put together officers manuals for the chapters.

Legislative Business; Butch; he said they are not getting feedback from chapters. Butch said that there will be a mandatory helmet bill and an mandatory seat belt bill will be presented at the Legislature in 1987. Butch and Dr. Dave need people to get involved. They need more communication from chapters on what is going on in their areas back to Butch and Dr. Dave.

An OPEN LETTER to every Chapter, Chapter Officer and member, explaining Article 5...
4 - HOW Chapter probation works and HOW to comply with OUR Rules of Operation.

Article 5...# 4 reads in part - to remain a Chapter in good standing of A.B.A.T.E. of Oregon, Inc., a Chapter must submit quarterly financial reports to the State Treasurer, send copys of meetings minutes to State Coordinator with-in one (1) week of the meeting, and submit a monthly Chapter report to the Newsletter Editor by the 15th of the month.

Any Chapter in non-compliance with any of the above three (3) requirements will be automatically on probation, untill brought into compliance, maximum time 90 days.

Below is a brake down on what the first paragraph of Article 5...# 4 is asking for.

QUARTERLY REPORTS: The year (12 months) is broke down into 4 quarters.
First Quarter - Jan, Feb, March - due at the April State Board meeting.
Second Quarter - April, May, June - due at the July State Board meeting.
Third Quarter - July, Aug, Sept - due at the Oct State Board meeting.
Fourth Quarter - Oct, Nov, Dec - due at the Jan State Board meeting.

COPYS OF MEETINGS MINUTES: God help me, I don't know how to explain - send copys of meetings minutes to State Coordinator (me) with-in one (1) week of the meeting, any plainer.

NEWSLETTER REPORT: Chapter Newsletter input must be received at P. O. Box 4504, Portland, Oregon 97208, on or before the 15th of every month - not the 16th or 17th. Most Chapters list some of the past activities (runs, partys, etc.) and talk of up-coming events. This is YOUR Chapters chance to be heard by most of the total States membership.

Now for the part of the paragraph that talks of what will happen to a Chapter if they don't comply with the above three (3) requirements.

When a Chapter (any Chapter, even my own, Washington Co) is in non-compliance with OUR Rules of Operation, they are placed on probation - no if's, and's or but's.

UNTIL BROUGHT INTO COMPLIANCE, is the magic part of the sentence.

MY letters placing Chapter on probation are self explanatory.

1. The date officialy placed on probation.

2. The reason for probation.

3. How long the Chapter has to bring it (the Chapter) into compliance.

4. The magic letter of responce from the Chapter as to why they did not comply with OUR Rules of Operation, Article 5...# 4.

Now for an explanation on - MAXIMUM TIME 90 DAYS - it means what it says. Remember the Bend Chapter, (Oct 1982 - Aug 1986) OUR Rules of Operation were carried out to the letter and there Charter was suspended for non-compliance with OUR Rules of Operation, Article 5...# 4.

Probation is still being handled the same at this point in time (12-6-86) as it was handled in July of 1985, when I was first elected to be YOUR State Coordinator.

If any Chapter is having a problem complying with OUR Rules of Operation, please get in touch with me (DEACON) at 359-9364, I am YOUR State Coordinator and I want to help you stay a Chapter of A.B.A.T.E. of Oregon Inc.

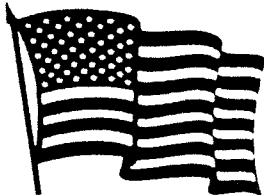

DO'S AND DON'TS OF LETTER WRITING:

Read these helpful hints carefully before you begin to compose your letters to your legislators. These hints will help you to write effective and persuasive letters.

- 1) Open with "Dear Senator" or "Dear Representative".
- 2) Close with "Sincerely".
- 3) Be brief, business like, and specific.
- 4) Be reasonable.
- 5) Support your arguments with examples from your riding, personal or business experience.
- 6) Be yourself.
- 7) Tell exactly where you stand on an issue.
- 8) Be polite (Be nice to him if you expect him to be nice to you).
- 9) Be appreciative of his efforts. ("Thank you for taking time to read my letter", or something of that nature)
- 10) Include your return address.
- 11) Make sure that you spelled all of the words correctly.

No legislator would be impressed by a sloppy letter. If you plan on making a phone call, do the following:

When he answers, give your name, town, and legislative district. State your opinions just as you would in a letter. You should prepare your comments according to the list above so that you get your point across in a convenient amount of time.

You should start your letter writing campaign immediately. Don't put this off until tomorrow. Tomorrow may be too late, and all of the work we have done will be down the drain.

HOW TO CONTACT YOUR LEGISLATORS:

- 1) See who represents you first.
Each district in Oregon has so many legislators, representatives and senators. These legislators know that you vote and you influence the votes of others around you.

REASONS FOR NOT CONTACTING YOUR REPRESENTATIVE AND SENATOR:

- 1) You don't care about helmet laws and rider education programs.
- 2) You're too lazy and would rather sit back and complain.
- 3) You're too busy and have more important things to do.
- 4) You can't afford a 20¢ stamp.
- 5) You're still mad at the phone company because a call now costs 25¢ instead of 10¢.
- 6) You don't know who to write or what to say.
- 7) Other: Please write your excuse below.

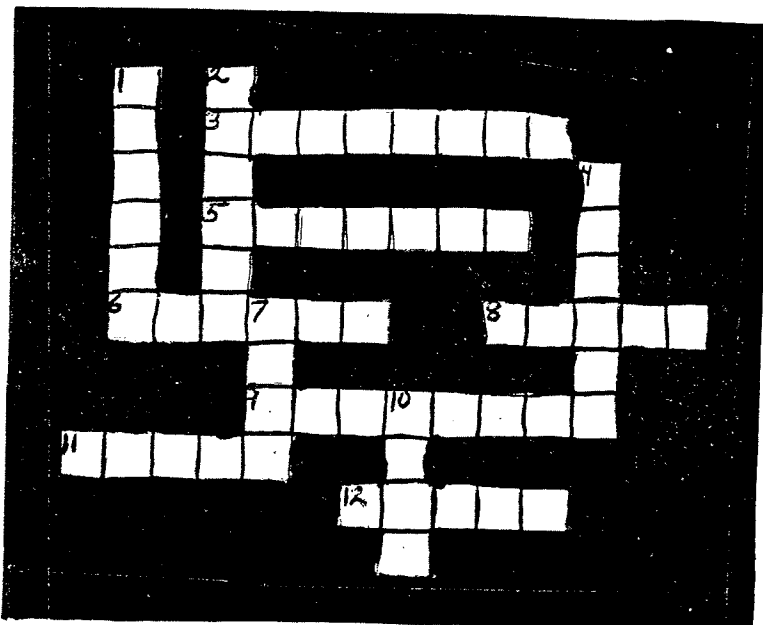

From Seashore to Seashore.

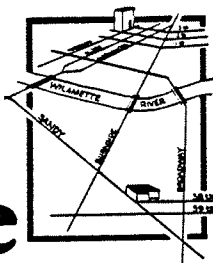
